RENTAL AGREEMENT

THIS IS A LEGAL CONTRACT, PLEASE READ IT THOROUGHLY BEFORE SIGNING. By signing this document, you're agreeing to the terms and conditions set forth herein. RELEASE AND ASSUMPTION OF RISK (WAIVER)

We deliver to the address specified by the renter. Renter grants Athens Bounce House Rentals, herein after referring to as "ABHR," the right to enter the property for the delivery, set-up, and pick up of the unit at the agreed upon time specified in this agreement. Renter assumes full responsibility for the unit(s) along with all accessories during the rental period. Renter understands and acknowledges that the activities to be engaged in through his/her rental of an interactive amusement game(s), obstacle course(s), slide(s), bounce house/jumper(s), and/or other amusement equipment may bring with them both known and unanticipated risks to guests and oneself. Those risks include, but are not limited to falling, slipping, crashing, and colliding and could result in injury, illness, disease, emotional distress, death and/or property damage to oneself or his/her guests. Therefore, renter voluntarily release, indemnify, hold harmless and discharge ABHR from all liabilities, claims, demands, actions, or rights of actions, whether, personal to renter or to a third party which are related to, arise out of or are in any way connected with his/her rental of any interactive inflatable game including those allegedly attributed to negligent acts or omissions. Renter agrees to reimburse ABHR any reasonable attorney's fees in the defense of any such liability claim, demand, action or right of action. If renter filed a cause of action against ABHR, he/she agrees to do so solely in the state of Georgia, and further agrees that the substantive law of said state shall apply in such action without regard to the conflict of law rules of the state of Georgia. Renter agrees that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full effect. Renter acknowledges that he/she has adequate homeowner's insurance, tenant's insurance, or other liability insurance to cover any bodily injury or property damage which may occur to oneself or his/her guests, from the use of the unit being rented or else renter agrees to solely bear the costs of such injury or damage. Rules: Renter agrees to always supervise both the equipment and its use while said unit is in the possession of the renter. Accompanying this contract are directions for use and safety rules that renter agrees to follow and always utilize during the operation and use of the interactive inflatable game(s). Renter understands that he/she has the right to cancel the reservation due to rain, extreme temperature, or extreme winds, however, there will be no refund, but renter will be qualified to receive full credit for a future date. After possession of the unit(s), there will be no discounts or refunds due to unfavorable weather conditions even if the unit is unusable due to bad weather. Furthermore, renter(s) agree to not operate the unit when winds exceed twenty miles per hour. Renter acknowledges and certifies that he/she has had sufficient opportunity to read this entire document, that he/she understands its contents and that he/she freely, intelligently and without duress of any kind, agrees to be bound by its terms.

Security Deposit: A non-refundable security deposit of \$50 per unit is required to hold the inflatable unit in reservation. Renter understands that the deposit will be forfeited if reservation is cancelled for any reason, except for inclement weather. In such an instance full credit will be given for a future event. No credit after delivery and set-up. ANY UNIT NOT RENTED AS A WATERSLIDE WILL INCUR A \$75 DRYING FEE IF FOUND TO BE WATERED IN ANYWAY OR BY ANYONE DURING RENTER'S POSSESSION. JUMPERS, COMBO UNITS, INTERACTIVE GAMES, AND DRY SLIDES ARE NOT TO BE USED WET. If a unit is damaged because of misuse or failure to follow safety rules or procedures, the renter agrees to pay for the cost of such repairs/replacement.

RULES and REGULATIONS

- The area required for the club house MUST be at least 24L×24W×16H.
- The area required for the obstacle course MUST be at least 34L×15W×10H.
- The area required for the 13X13 jumper MUST be at least 15L×15W×16H.
- The area required for the 15X15 jumper MUST be 18Lx18Wx14H.
- Units must be placed on a leveled ground.
- All pets must be restrained while the bouncer and equipment are present.
- Electricity must be available within 100 feet.
- The renter must provide ABHR personnel with sufficient access to the activity area for the purpose of setting up and taking down the equipment.
- It is the responsibility of the renter that all swimming pools and hot tubs are properly enclosed or supervised while children are using the bouncers, slides, and equipment.
- The renter agrees to provide monitoring and instructions to all participants on the proper use of the equipment as they are laid out in the rental agreement prior to the use of the equipment.
- No one under 18 MUST use any of ABHR's equipment without adult supervision.

Bouncers Rules:

- Adult Supervision is always required and for any rental unit.
- No shoes, food, silly strings, gums, sand, face paints, or drinks allowed in the equipment.
- No SHARP objects, pins, loose belts/buckles, barrettes, etc. allowed in the equipment.
- Remove eyeglasses and pierced earrings. NO pets of any kind.
- Do not climb on walls of the bouncer, do not allow the users to all run in the same direction and bounce off walls (this may cause unit to tip over).
- Do not bounce near the doorway. No flipping allowed.
- Do not hold or hang on the string netting.
- No more than 8 small children at one time in the bounce house, reducing the number for larger children. Children of the same age should be grouped together.
- It is recommended that pregnant women, individuals on medications, individuals with physical ailments, casts, heart condition, and those under the influence of alcohol or drugs DO NOT use any of the inflatables.
- No cigarettes, cigars, or campfires should be anywhere near the vinyl (it is flammable). Campfires and fireworks should be at a distance of no less than 100ft and a further distance in windy conditions to prevent amber from damaging the equipment.
- Units must be set up on a flat surface.
- Do not water down any dry unit due to hot weather.
- The capacity of our bouncers is rated at: 400lbs for our 13x13 unit, 500lbs for our 15x15 unit, and 600lbs for our 5 in 1 combo units.

Slide Rules:

- Only one child should slide in each lane at a time.
- ABSOLUTELY NO JUMPING FROM THE TOP OF THE SLIDE TO THE BOTTOM. Riders MUST slide down their feet first.
- When the unit is wet, it is very fast. Extra caution must be exercised.
- **AT NO TIME SHOULD SHOES BE WORN ON UNITS BECAUSE THEY CAN DAMAGED THE UNIT.**
- **FOR OVERNIGHT RENTERS:** In addition to our general rules: Inflatable must be operated in a well-lit location and operator must be always present. Renters understand and acknowledge that the blower is to be removed from the inflatable game and locked up in a secure location overnight. Overnight Renters' Initial: ().
